











What I had felt then gave me an insight into what might have sustained V.D. Savarkar in the Cellular Jail at Andman while undergoing 50 years of rigorous imprisonment without hope of being ever set free. When I visited that cell in 1998, I stood outside wondering how he could maintain his poise, fervour, and poetic sensibility over the 11 years of the grueling distress. But my mind turned a teacher. I saw massive peepal trees and banyan trees at a distance. Savarkar could have seen them from his cell itself. He must have maintained his equilibrium and creativity just by gazing most of the times at the trees whose dense twigs and leaves might have appeared to him the bowers in which Krishna might have manifested Himself providing him Light and Delight. My reading of the lines of the Kamla strotam that Savarkar had etched, with a tiny hook on the plastered wall, helped me understand the force that might have sustained this hero. It was Krishna.
